

Does Azerbaijan offer reintegration assistance to returnees?

Despite the challenging year, IOM Azerbaijan is continuing its efforts to implement reintegration assistance to returnees- the citizens of Azerbaijan who voluntarily returned to the country of origin under the Assisted Voluntary Return and Reintegration (AVRR) projects.

What reintegration assistance is provided by IOM Azerbaijan?

The main part of reintegration assistance provided by IOM Azerbaijan is assistance to returnees with the establishment of income-generating activities such as small-farming (sheep, cattle breeding), businesses in the service sector (taxi), trade, and small-scale production that aims to benefit the returnees and their families.

Did IOM Azerbaijan provide cash assistance to AVRR returnees?

In the first quarter of 2021 within its AVRR projects, IOM Azerbaijan provided cash assistance to 46 returnees and 76 returnees received in-kind assistance.
