How much will EDF Nouveaux business invest in energy storage?

Investment in research into storage for the power system will double, reaching EUR70 million for the 2018-2020 period. How big is France's energy storage capacity?

Global energy storage capacity was estimated to have reached 36,735MW by the end of 2022 and is forecasted to grow to 353,880MW by 2030. France had 90MW of capacity in 2022 and this is expected to rise to 359MW by 2030.
