What happens if Talos doesn't acquire enough Talos shares?

Through Dec. 16, 2025, Control Empresarial de Capitales S.A. de C.V. has agreed to not acquire enough Talos shares to bring the company's total ownership of Talos to over 25%. As a result of the agreement, Talos will terminate the poison pill measure it enacted in October.

Does Talos Mexico own Zama?

Talos Mexico holds a 17.4% interest in the Zama field. After closing, Talos will own 20% of Talos Mexico, while Zamajal will own 80%. The deal "is expected to close upon the receipt of all regulatory approvals," Talos said. In a transaction last year, Zamajal acquired 49.9% of Talos Mexico for \$124.75 million.

Did Talos buy Mexico's richest man?

Houston-based Talos Energy Inc. (NYSE: TALO) has made a deal with Mexico's richest man a couple months after adopting a poison pill measure to fend him off. Through Dec. 16, 2025, Control Empresarial de Capitales S.A. de C.V. has agreed to not acquire enough Talos shares to bring the company's total ownership of Talos to over 25%.

Why did Talos adopt a limited-duration Stockholder rights plan?

Talos said it adopted a limited-duration stockholder rights plan, commonly known as a poison pill, "solely in response to the continued accumulation" of shares by Control Empresarial. The measure aimed to prevent any investor from gaining more than 25% of the company's shares.
