

What is public procurement in Sweden?

Public procurement is a statutory purchasing process that aims to ensure that public purchases are opened up to competition and that public funds are used as effectively as possible. In Sweden, public procurement is governed by the Public Procurement Act (commonly referred to as the LOU, the abbreviation of its Swedish name).

Which EU directives govern public procurement in Sweden?

The EU directives 2014/24/EU on public procurement, 2014/25/EU on water, energy, transport and postal services sector, 2014/23/EU on concessions and 2009/81/EC on defence and security on the website of the European Union. In Sweden, public procurement is governed by the Public Procurement Act (2016:1145).

What does the Swedish procurement agency do?

The Agency has overall responsibility for developing, administering and supporting procurements conducted by the contracting authorities and units. Supervision of public procurements is carried out by the Swedish Competition Authority, which can also bring court actions regarding procurement fines..

How do contracting authorities comply with the Swedish procurement rules?

By complying with the Swedish procurement rules, contracting authorities and entities comply with the obligations arising from EU law. Note! This document is from November 2017 and has not been updated based on the changes in the law that entered into force on February 1, 2022.
