Is Nexen a Canadian company?

CNOOC Petroleum North America ULC, formerly known as Nexen, is a Canadian oil and gas company based in Calgary, Alberta. Originally the Canadian subsidiary of US-based Occidental Petroleum (known as Canadian Occidental Petroleum or CanOxy), it became an independent company, Nexen, in 2000.

Does Nexen sell natural gas?

How much money does Nexen receive from shareholders?

Nexen's common stock shareholders received cash proceeds of US\$27.50, without interest, whereas preferred stock shareholders of Nexen received cash proceeds of CAD \$26, plus accrued and unpaid dividends without interest.
