Gibraltar's renewables division includes SolarBOS, an electrical balance of system solutions provider, TerraSmart, and Sunfig. SolarBOS was added in 2018, while TerraSmart was acquired this year. TerraSmart is a solar foundations manufacturer that offers turnkey installation and civil services.

RBI Solar is owned by Gibraltar Industries. Gibraltar Industries acquired RBI Solar in 2015. Gibraltar also owns SolarBOS, an electrical balance of system solutions provider, which it added to its renewables division in 2018. This year, Gibraltar acquired TerraSmart and Sunfig.

Are Gibraltar & TerraSmart a good investment?

Gibraltar and TerraSmart are among many U.S. solar companies that have joined forces over the years. Vietas said such mergers and acquisitions are a positive sign. "I think it signals a healthy, growing market," he said. "It also signals the fact that more investment wants to come into renewables.
