(STI Norland). Array bought a 100% stake in STI for roughly US\$652 million (US\$401 million in cash and 13.9 million shares of Array common stock).

Are NEXTracker & array technologies the same company?

Nextracker (NASDAQ:NXT) and Array Technologies (NASDAQ:ARRY) both operate in the same commercial space, providing solar-tracking equipment and technology mostly for utility-scale solar power installations.

How much did array buy STI?

Array bought a 100% stake in STI for roughly US\$652 million (US\$401 million in cash and 13.9 million shares of Array common stock). The deal was expected to close this quarter in a move that Array said makes it the "largest solar tracker company in the world" when based on 2020 order bookings.
