Did European energy secure a contract for a battery project in Poland?

European Energy successfully secured a contract for several battery projects in Poland. The Polish Transmission System Operator Capacity Market auction has awarded a 17-year contract, indexed to inflation, for four battery projects to European Energy.

How many battery projects are being built in Poland?

The Polish Transmission System Operator Capacity Market auction has awarded a 17-year contract, indexed to inflation, for four battery projects to European Energy. The four projects have a combined capacity of 114 MW and are located in the north-western part of Poland. European Energy has 24 months to bring the projects to the ready-to-build stage.

Will EPC contracts provide for the handover of a solar facility?

EPC Contracts will not provide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed.

Should you choose an EPC contract for a solar project?

Given the significant monetary value of EPC Contracts, and the potential adverse consequences if problems occur during construction, the lowest price should not be the only factor used when selecting a Contractor.
