Does Ukraine need international assistance to protect energy infrastructure from attacks?

We acknowledge the needfor international assistance to protect energy infrastructure from attacks,including through the strengthening of Ukraine's air defense capabilities by the committed countries,and reaffirm our readiness to continue providing such assistance.

How will the energy community support Ukraine?

We commit to continue to support Ukraine with significant emergency assistanceto help repair and stabilise the energy grid and prepare for this winter. Over EUR300 million in funding has been provided to the Energy Community's Ukraine Energy Support Fund for the restoration and protection of Ukraine's critically damaged energy infrastructure.

Why did the G7+ Ukraine energy coordination group meet at cop29?

We,the members of the G7+Ukraine Energy Coordination Group,met on the margins of the COP29 to reaffirm our unwavering support for Ukrainein the face of Russia's illegal,unprovoked and unjustified war of aggression against Ukraine and its brutal and unjust attacks on Ukraine and its energy infrastructure.

How much funding has been given to Ukraine's energy infrastructure?

Over EUR300 millionin funding has been provided to the Energy Community's Ukraine Energy Support Fund for the restoration and protection of Ukraine's critically damaged energy infrastructure. Members of this group are also supporting the provision and procurement of a least 65 high voltage autotransformers and 6 mobile gas turbine generators so far.

How did G7+ support Ukraine's energy sector?

Prior to March 2024,G7+partners mobilized over \$3 billion in financial and material supportto Ukraine's energy sector,including nearly EUR500 million in grant funding to the Ukraine Energy Support Fund (ESF),operated by the Energy Community Secretariat,for the rapid restoration of Ukraine's critically damaged energy infrastructure.
