Wartsila Oyj Abp (Finnish: [vartsila]), trading internationally as Wartsila Corporation, is a Finnish company which manufactures and services power sources and other equipment in the marine and energy markets.

The former Wartsila Marine Turku Shipyard is now owned by Meyer Werft under its Meyer Turku subsidiary and the Helsinki shipyard is operated by a company of the same name owned by the Canadian Davie Shipbuilding. Wartsila is a provider of power plants in distributed and flexible power generation.
